TERMS AND CONDITIONS OF RESIDENCE

You should be aware that:

1. Your residence is conditional upon signing your acceptance of these Terms and Conditions of Residence.
2. The Bond will be held against the following items:
 - ➔ Damage to NFIH property, including the room and items provided in the room
 - ➔ Any unpaid debt, rent or other, incurred to NFIH
 - ➔ Monetary penalties for misconduct
 - ➔ Cleaning fees for room left in an untidy condition (room must be tidy and free from personal debris, and the fridge must be emptied and wiped)

Any unused bond will be refunded via the selected payment option up to 2 weeks after departure.
3. Failure to maintain your account per the stipulated conditions at all times may result in future reservations being declined.
4. Residents who wish to leave prior to the agreed expiry date of their residency period are required to adhere to the conditions of their contracted rates (see NFIH 2009 Rates, page 3).
5. Residents wishing to extend their stay beyond the agreed timeframe are required to inform North Flinders International House office staff. NFIH cannot guarantee any extensions, thus you may be required to change rooms or source alternate accommodation, and your rate may change.
6. Upon signing these Terms and Conditions you are agreeing to adhere to Charles Darwin University's Rules of Conduct, Charles Darwin University's By-laws and the North Flinders International House Rules of Conduct. See www.cdu.edu.au/governance/bylaws.html. www.cdu.edu.au/nhif/conduct/rules.html
7. **All** relevant information for applications and payment must be supplied prior to a reservation being considered.
8. Check-in time is 1 pm. Check-out time is 10 am.
9. Applications are evaluated in the order they are received and no special considerations will be made.
10. Residents who remain at NFIH outside of the semester dates may be required to move rooms.
11. Room moves requests will only be granted in extenuating circumstances and will incur a \$100 cleaning and administration fee upon approval.
12. Specific room numbers will not be guaranteed until the room keys are offered, except by the authority of the manager.
13. A copy of this document will be kept on file.
14. Academic results may be withheld if a debt to the North Flinders International House has been incurred.
15. Once approved, no postponement of arrival date will be allowed.
