



MAR20324 Certificate II in Maritime Operations (Coxswain Grade 1 Near Coastal)

DESCRIPTION

This qualification applies to people working in the maritime industry seeking an Australian Maritime Safety Authority (AMSA) certificate of competency of Coxswain Grade 1 Near Coastal.

Duties and Functions:

Duties and functions for which AMSA certificate of competency is required are listed in the MAR Maritime Training Package Companion Volume Implementation Guide.

Licensing/Regulatory Information

This qualification is required to obtain an AMSA certificate of competency as a Coxswain Grade 1 NC as specified in Marine Order 505.

AMSA certification will require:

- achieving [MAR20324](#) Certificate II in Maritime Operations (Coxswain Grade 1 Near Coastal),
- short range operator Certificate of Proficiency issued by ACMA (or higher qualification),
- qualifying sea service as specified in Marine Order 505,
- meeting the medical requirements specified in the Marine Order 505 and
- passing final assessment specified in Marine Order 505.

Seafarers seeking certification should check with AMSA.

ELIGIBILITY/ENTRY REQUIREMENTS

A Language, Literacy, Numeracy and Digital Literacy (LLND) evaluation helps identify any areas where you may need additional support to help you achieve your goals.

To gain entry into MAR20324 Certificate II in Maritime Operations (Coxswain Grade 1 near Coastal), it is a CDU recommendation that students have completed at least half of the applicable qualifying sea service before commencing.

Qualifying sea service for application of licence:

- 30 days with a completed and approved Task Book, i.e. 15 days for entry to course
- 150 days without a completed and approved Task Book, i.e. 75 days for entry to course

A suitable record of sea time already obtained is to be recorded in the student's file, i.e. an approved record book or statutory declaration from vessel skipper/s.

Students must hold a current First Aid Certificate ([HLTAID011 - Provide First Aid](#)).

Vessel operation and maintenance training occurs on the CDU vessel or hired vessel whilst moored and on the water to train and practice manoeuvrability.

MARC037	Operate inboard and outboard motors
MARC038	Operate main propulsion unit and auxiliary systems
MARF028	Follow procedures to minimise and fight fires on board a vessel
MARF029	Meet work health and safety requirements
MARF030	Survive at sea using survival craft
MARF060	Apply basic survival skills in the event of vessel abandonment
MARH013	Plan and navigate a passage for a vessel up to 12 meters
MARI003	Comply with regulations to ensure safe operation of a vessel up to 12 metres
MARJ006	Follow environmental work practices
MARK007	Handle a vessel up to 12 metres
MARN008	Apply seamanship skills aboard a vessel up to 12 metres
HLTAID011	Provide First Aid (<i>credit transfer only</i>)
