#### **DESCRIPTION**

This qualification reflects the role of individuals employed as beauticians to provide a range of beauty services including nail, waxing, lash and brow, and basic make-up services.

These individuals possess a range of well-developed technical and customer service skills where discretion and judgement are required and are responsible for their own outputs. This includes client consultation on beauty products and services.

Work is typically conducted in beauty, waxing, brow, and nail salons.

The skills in this qualification must be applied in accordance with Commonwealth and State or Territory legislation, Australian standards, and industry codes of practice.

No occupational licensing, certification or specific legislative requirements apply to this qualification at the time of publication.

This course is suitable for trainees who have a Training Agreement (Traineeship) with an employer.

# **ELIGIBILITY/ENTRY REQUIREMENTS**

A Language, Literacy, Numeracy and Digital Literacy (LLND) evaluation helps identify any areas where you may need additional support to help you achieve your goals.

To gain entry into SHB30121 Certificate III in Beauty Services, candidates require:

- A completed Year 11 or equivalent education, Language, Literacy, Numeracy and Digital Literacy assessment and interview.
- Successful completion of a pre-enrolment Language, Literacy, Numeracy and Digital Literacy (LLND) assessment and interview is essential for success in this program

Students undertaking this qualification as a Trainee must have a training contract with their employer and Apprenticeships Northern Territory.

# **Beauty Kits**

Students are required to purchase a lash lift kit and an eyelash extension kit.

- The lash lift kit can be purchased from Elleebana and costs approximately \$202.56.
- The eyelash extension kit can be purchased from Graft a Lash and costs approximately \$215.00.
- It is recommended that you also purchase a make-up brush set.

Information on where to purchase these kits will be provided on enrolment.
