#### **PURPOSE**

To recognise and reward First Nations students on their academic achievements in 2023.

### **ELIGIBILITY CRITERIA**

- > Must be enrolled in the Tertiary Enabling Program (TEP), an undergraduate course, or a post-graduate course (excluding research degrees).
- > Is a First Nations student.
- > Students who commenced their course in, or prior to, Admission Period 1, 2023, must have successfully completed a minimum of 20 credit points (cp) in both Admission periods 1 and 2 (40 cp total). Students who commenced their course in Semester 2, 2023 must have successfully completed at least 20cps.
  - o Admission period 1: Semester 1, Intensive periods 1-3
  - o Admission periods 2: Semester 2, Intensive periods 4-5

### OTHER CONDITIONS

Students are not required to apply for this grant. Eligible students will receive an email notification if they meet the eligibility criteria outlined above.

Students must accept the offer of the scholarship by the specified due date in the offer email. Scholarships cannot be deferred.



### **PAYMENT OF BENEFITS**

- > Each recipient will be paid by electronic funds transfer (EFT) to their nominated bank account.
- > Payment will be made within 5-10 business days after receipt of the Scholarship Acceptance E-form
- Payments are subject to the recipient satisfying ongoing eligibility criteria as outlined in this document and the Scholarships and Prizes Policy.

#### **DURATION**

The duration of the Scholarship is one (1) semester or when one of the following is true:

- > The maximum Scholarship value has been exhausted;
- > The student has completed their course of study;
- > The student no longer meets the ongoing eligibility of the Scholarship.

## Other obligations and conditions:

- The offer of the Scholarship is made subject to information provided by the recipient being true and accurate.
- By accepting the offer of the Scholarship, each recipient agrees to the Scholarship Terms and Conditions.
- > The recipient is responsible for advising the Scholarships Officer of any changes in circumstances that would make them ineligible for continuation of the Scholarship, e.g. reducing study load to part-time, applying for an intermission or transferring to another course.

## TERMINATION OF RECIPIENT'S SCHOLARSHIP

The Scholarship will terminate:

- > If the recipient ceases to meet the eligibility criteria; or
- > If the recipient fails to meet the ongoing eligibility criteria for two (2) teaching periods; or
- > If the recipient withdraws from their course; or
- > If the recipient breaches any conditions of the Scholarship; or
- If CDU determines that the student is guilty of serious misconduct
