The CDU Master of Business Administration (MBA) (Executive) Scholarship will be offered to eligible students commencing in Intensive 1 through 5 of 2025 in the Master of Business Administration (Executive) - SBAD02. The terms, conditions, and eligibility requirements listed below apply to all recipients of the CDU MBA (Executive) Scholarship.

#### **ELIGIBILITY CRITERIA**

- 1) The CDU MBA (Executive) Scholarship is awarded at the discretion of the University to students who are applying for the Master of Business Administration (Executive) SBAD02, and are members of the following organisations:
  - o NT Chamber of Commerce; or
  - o Haymarket Chambers of Commerce; or
  - o NTIBN
- 2) Students must provide evidence of membership (organisational or individual) with one of the organisations listed in clause 1 by providing a completed Third-Party Employer Authorisation Form. The Third-Party Employer Authorisation Form is included in the appendix below.
- 3) The CDU MBA (Executive) Scholarship is only available for Australian or New Zealand Citizens, or those who hold Permanent Residency status in Australia.
- 4) The CDU MBA (Executive) Scholarship is only available for students commencing study in Intensive 1 through 5, 2025. You will not be considered eligible if you have previously enrolled in the Master of Business Administration (Executive) course.

# TERMS AND CONDITIONS AND ONGOING ELIGIBILITY

- 1) The CDU MBA (Executive) Scholarship cannot be used in conjunction with any other CDU tuition fee discount.
- The scholarship is non-transferable, cannot be redeemed for cash or any other benefit, and applies exclusively to tuition fees for the eligible course.
- 3) The CDU MBA (Executive) Scholarship is valid for the entire duration of the course, provided all conditions of the scholarship are met.
- 4) The scholarship can only be applied to the recipient's first enrolment in the Master of Business Administration (Executive) and cannot be applied to any future applications for the same course.
- 5) The scholarship cannot be applied to any units undertaken with a partner institution or organisation.
- 6) The recipient must notify the scholarships team by emailing <a href="mailto:scholarships@cdu.edu.au">scholarships@cdu.edu.au</a> if any of the following circumstances arise:
  - a) The recipient discontinues their studies, or
  - b) The recipient defers or is approved for a leave of absence, or
  - c) The recipient changes their course of study, or
  - d) Any other circumstances that may affect the recipient's eligibility for the scholarship.
- 7) The CDU Master of Business Administration (Executive) Scholarship remains valid whilst the recipient:
  - a) remains enrolled on a part-time or full-time basis in the Master of Business Administration (Executive).
- 8) The CDU MBA (Executive) Scholarship will be terminated if the recipient:
  - a) fails to fulfill the ongoing eligibility requirements, such as:

- i. Graduates from their nominated course; or
- ii. cancels their enrolment at CDU; or
- iii. has their enrolment cancelled at CDU; or
- iv. the recipient ceases to be enrolled in the approved eligible course, or
- b) breaches the terms and conditions of the discount; or
- c) is found by the University to have breached the <u>Code of Conduct – Students</u> or any other CDU policies.
- has provided false, inaccurate, incomplete or misleading information to obtain the discount
- 9) If the discount is terminated, the recipient will be notified, and an invoice for the full tuition fee may be issued. Appeals can be made through the University's complaints and appeals process.

The scheme will operate under and in terms of CDU's <u>Units and Courses Policy</u>, including but not limited to the <u>Enrolment Policy</u>, <u>Scholarships and Prizes Policy</u>, <u>Admissions Policy</u>, <u>Domestic Student Fee Policy</u>, and <u>Higher Education Academic Progression Policy</u>.

CDU reserves the right to amend these terms and conditions or withdraw the scholarship scheme at its discretion and without prior notice. However, students already enrolled and paying tuition under this scheme will continue to benefit for the duration of their eligible programme, provided they meet the scheme's terms.
